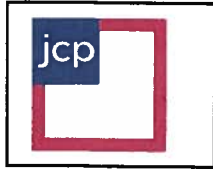




SOUTHERN OREGON KIDSPREE

Dear KidSpree Volunteer:

The 2014 Southern Oregon KidSpree is planned for **Saturday, August 9th, 2014 from 7:00a.m. to about 9:00a.m.** We need your help to continue to serve the children of our community. **** **Please return your volunteer information ASAP.** ****

ORIENTATIONS: Tuesday, August 5th @ 6:00pm, Wednesday, August 6th @ 6:00pm and Thursday, August 7th @ 6:30 pm. **It is MANDATORY that you attend one of these sessions if you wish to volunteer, even if you have done it in the past.** They will be held at JCP in the staff lunchroom (near the beauty shop) on the lower level and will last approximately 1 hour.

We are required to run background checks on all our volunteers. They are effective for 3 years. It is imperative that the children are safe. The criminal history checks cost \$5.95 per volunteer and will be performed through IntelliCorp. If you are unable to pay the \$5.95 for the criminal record check and want to volunteer, please let us know, we do have some resources to help pay the fee. Please do not let this stop you from helping. We need you! Please return the enclosed application **no later than July 15th!**

A new application is needed each year even though criminal records checks are only done every 3 years. We do not keep applications from year to year. If you are a returning volunteer within the last 3 years we will indicate on your application if a new criminal check is due.

We are sensitive to the concerns of volunteers and their privacy as well as the security of their information. Only 3 people on the committee are allowed to have access to the information provided by volunteers. All applications and records will be kept in a locked file cabinet at United Way. We do not keep social security numbers or birthdates on file after the criminal records check is complete. They are shredded.

We are always looking for more volunteers, so please share this information with friends and associates. Over the last 23 years we have served approximately 5,800 kids, so our need for volunteers is great. **WE NEED YOUR HELP!**

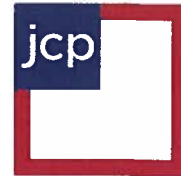
